**BUYER'S RIGHT TO RESCIND**

Pursuant to Hawaii law (Hawaii Revised Statutes Chapter 484) and the Lot Purchase Agreement (the "Agreement") between Seller and Buyer relating to the Lot, Buyer has the right to rescind the Agreement and to receive a refund of all sums paid by Buyer under the Agreement, with no penalty to Buyer, within 30 days after the date Buyer signed the Agreement. Any statement by Buyer clearly stating the intention to rescind the Agreement may be used to rescind the Agreement. The form provided on the next page may be used for such purpose.

If a written statement is delivered to Seller by U.S. mail (first class, with postage prepaid), then it must be postmarked no later than midnight on the 30th calendar day following the date Buyer signed the Agreement. If a written statement is delivered to Seller in some other manner, then it must be received at the above address no later than midnight on the 30th calendar day following the date Buyer signed the Agreement. Failure to so act shall result in a waiver of Buyer's right to refund and rescission.

The undersigned Buyer acknowledges receipt of this written notice of the right to rescind the Agreement and cancel the transaction.

**NOTE: PROVIDED THE PUBLIC OFFERING STATEMENT HAS BEEN PROVIDED TO BUYER, BUYER WILL BE DEEMED TO HAVE EXECUTED THIS RECEIPT IF BUYER FAILS TO EXECUTE AND RETURN THIS RECEIPT TO SELLER WITHIN 30 DAYS AFTER SIGNING THE AGREEMENT.**
